TREASURER'S REMARKS

The Treasurer welcomed everyone to Convocation.

The Treasurer advised that benchers have gathered virtually today, and that she is joining Convocation from Windsor, which sits on the traditional territory of the Three Fires Confederacy of First Nations, which includes the Ojibwe, the Odawa, and the Potawatomi.

She recognized and respects the longstanding relationships with First Nations people in this place, in the One Hundred Mile Windsor-Essex Peninsula and the Straits, le détroits, of Detroit. She advised that for this Convocation, benchers are participating across the province and perhaps elsewhere, and across many First Nations territories. She recognized the long history of all the First Nations in Ontario and the Inuit and Métis peoples and thanked all Indigenous peoples who lived and live in these lands for sharing them with us in peace.

The Treasurer noted that the 8th annual Access to Justice Week began with a sunrise ceremony on Monday, October 23, 2023 guided by Elder Myeengun Henry. The Treasurer advised that the program was on the theme of "10-year anniversary of Canada's Justice Development Goals".

The Treasurer announced that Fanshawe College has been selected to collaborate with the Law Society on the design and development of the training program for paralegals for the Family Legal Services Provider (FLSP) credential, and is expected to launch in January 2025.

The Treasurer advised on the protocol for Convocation via videoconference.

The Treasurer advised that the Tribunal Committee Report is being removed from the agenda today and will be brought back to a future Convocation.

AUDIT & FINANCE COMMITTEE REPORT

Re: Law Society of Ontario 2024 Budget

It was moved by Mr. Troister, seconded by Ms. Lomazzo, that Convocation approve the Law Society's 2024 Budget as presented in the report, including:

- a) Annual fees for lawyer and paralegal licensees of \$1,956 and \$990, respectively,
- b) The use of fund balances to fund operations and mitigate annual fee increases totaling \$8,318,000 as defined below,
- c) A loan of up to \$5,675,000 from the Lawyer General Fund to the Capital Allocation Fund restricted to fund the Business and Technology Transformation Initiative (the "Transformation"),
- d) The transfer of \$3,500,000 from the fund balance of the Lawyer General Fund to the Capital Allocation Fund restricted to fund the Transformation, and
- e) The use of \$600,000 of available fund balance in the Capital Allocation Fund to fund facility preservation and infrastructure projects in 2024.
