



# Application for Foreign Legal Consultant – New Permit Under By-Law 14

## About Foreign Legal Consultant Permits

---

By-Law 14 requires lawyers licensed outside of Canada to apply to the Law Society of Ontario (Law Society) for a permit to give legal advice in Ontario respecting the law of a foreign jurisdiction. Applicants must meet the conditions outlined in the By-Law to qualify for a permit and must apply annually to the Law Society to renew their permit.

## Required Documents

**NOTE: If submitting more than one application on behalf of a firm, a separate document is required for each applicant.**

**1. Complete application form**

The Law Society may investigate or verify any information supplied in this application and may require further information from you before the application is approved. **Omissions or inaccuracies in responses may delay processing.**

If the space provided for any answer is insufficient, include a separate sheet that is signed and dated by the applicant with the application.

**2. Proof of payment or payment in the form of either:**

- A receipt for payment by credit card from the Law Society Store. To pay:
  - **For licensees**, login to the Law Society Portal at <https://portal.lso.ca>. Select “LSO Store” in the left panel and then “Other Fees”. Choose “FLC Permit Application Fee”. **Include the receipt with your application.**

The Law Society will not process applications submitted without proof of payment or a certified cheque or money order.

**3. Certificate(s) of Standing:**

Original Certificate(s) of Standing (dated within the last 30 days) from each law society or governing body of the legal profession of which you are or have been a member, inside and outside of Canada.

**Certificates of Standing must be forwarded directly from the governing or regulatory body to the Law Society by email or mail (addresses below). Digital versions are acceptable.**

**NOTES:** Your Certificate(s) of Standing must be replaced if it will be more than 60 days old at the time your application is ready to be approved by Complaints & Compliance. Applicants must remain entitled to practice in their home jurisdiction.

Do not submit a Certificate of Standing from the Law Society of Ontario if you are a licensee.

**4. Proof of Insurance:**

Include proof of professional liability insurance (e.g. Certificate of Insurance) for the giving of legal advice in Ontario respecting the laws of each foreign jurisdiction(s) for which you are applying for a permit, which is at least equivalent to that required of a lawyer who is licensed to practise law in Ontario (currently at least \$1,000,000 CAD per claim and \$2,000,000 CAD in the aggregate).

It is your responsibility to ensure that your insurance is valid for the duration of your Foreign Legal Consultant permit and that it meets the minimum requirements. The current year's coverage requirements can be found at: <https://www.lawpro.ca/your-policy/policy/>.

If your insurance is restricted to a certain practice area(s) or jurisdiction(s) (e.g. only immigration law or federal law), please provide the relevant pages from your policy confirming the restrictions.

**5. Curriculum Vitae:**

Include a letter from the supervising Foreign Legal Consultant who has agreed to supervise you confirming the supervision agreement.

I understand that I must have professional liability insurance coverage for the giving of legal advice in Ontario respecting the law of the foreign jurisdiction(s) for which I am applying for a permit, which is at least equivalent to that required of a licensee who holds a Class L1 licence for the licensee's practice of law in Ontario and that it must be current and valid for the duration of my permit. I have reviewed the LawPRO Standard Policy (#001) and confirm that the coverage provided by my professional liability insurance is at least equivalent to the coverage required for Ontario lawyers.

The Law Society limits the amount and type of personal information it collects, uses, or discloses to that which is necessary to carry out its responsibilities under the *Law Society Act*, its by-laws, and relevant rules, guidelines, and decisions of the Law Society's Convocation.
