

Application for Surrender of Licence to Practise Law Under By-Law 4

About Surrender of Licence to Practise Law

Licensees who no longer wish to practise law in Ontario as a barrister and solicitor may apply to the Law Society of Ontario (Law Society) to surrender their licence. Applicants are encouraged to review By-Law 4 for information about surrendering their licence.

The Law Society may not be able to approve your application if you are:

- a) the subject of a complaint, audit, investigation, search or seizure by the Law Society; or
- b) a party to a proceeding under Part II of the *Law Society Act*.

Submitting an application to surrender your licence will not prevent you from being suspended for failing to comply with any administrative or regulatory requirement.

Required Documents

Complete and submit the following:

1. Complete application form

The Law Society of Ontario (Law Society) may investigate or verify any information supplied in this application and may require further information from you before the application is approved. **Omissions or inaccuracies in responses may delay processing.**

If the space provided for any answer is insufficient, include a separate sheet that is signed and dated by the applicant and include it with the application.

2. Lawyer's Professional Indemnity Company (LAWPRO) release form (Part M) The Law Society will not be able to approve your application if there are outstanding claims against you in your professional capacity.

3. A. Proof of trust/mixed trust/estate accounts closure (Part D)

This requirement applies to sole practitioners engaged in the practice of law in Ontario during the last 3 years unless they are over the age of 65 and have already been approved by the Law Society to pay the Over 65 (Retired) Annual Fee (10% fee category).

OR

B. Proof of no signing authority over all trust/mixed trust/estate accounts (Part D)

This requirement applies to partners, associates, and employees engaged in the practice of law in Ontario during the last 3 years unless they are over the age of 65

and have already been approved by the Law Society to pay the Over 65 (Retired) Annual Fee (10% fee category).

If this requirement applies to you, please provide letter from the signing partner or your bank.

4. Location of active and/or closed files, wills, powers of attorney, corporate seals and corporate minute books (Part F)

This requirement applies to all licensees who engaged in the practice of law in Ontario unless they are over the age of 65 and approved by the Law Society to pay the Over 65 (Retired) Annual Fee (10% fee category).

5. Outstanding Annual Report Filing(s)

Licensees must complete all outstanding Annual Report Filing(s) through their account on the Law Society Portal before the application may be approved unless they are over the age of 65 and have been expressly exempted on application to the Law Society.
