The Law Society of Ontario may investigate or verify any information supplied in this application, and may require further information from you before the application is approved. **Omissions or inaccuracies in responses may delay processing.**

If the space provided for any answer is insufficient, attach a separate sheet that is signed and dated by the applicant and staple it to the application.

Submit a copy of the following documents:

- Issued Articles of Incorporation
- Issued Articles of Amendment (if any)
- Issued Articles of Continuance (if any)
- Issued Articles of Amalgamation (if any)

The articles must restrict both the business of the corporation and the ownership of shares of the corporation in accordance with the *Business Corporations Act* and the *Law Society Act*.

Submit proof of payment or payment in the form of either:

- A receipt for payment by credit card from the Law Society Store. To pay, login to the Law Society Portal at <https://portal.lso.ca>. Select “LSO Store” in the left panel and then “Other Fees”. Choose “Professional Corporations – Certificate of Authorization”.

Attach the receipt to your application.

- A certified cheque or money order in Canadian funds payable to the “Law Society of Ontario”.
