**ORDER**

THIS APPLICATION by the Applicant for a permanent injunction against the Respondents was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Notice of Application of the Law Society of Upper Canada, and the affidavits filed by the Law Society of Upper Canada, on hearing the submissions of the parties, Abdul Gabbar Khan appearing on behalf of himself, and with the consent of the parties, as provided in the course of the hearing, *save with respect to the issue of costs,*

1. THIS COURT ORDERS that the Respondents shall not and are permanently enjoined from, directly or indirectly, practising law or providing legal services. For greater clarity, the Respondents cannot rely on the exemptions set out in By-Law 4 enacted by the Law Society of Upper Canada.

2. THIS COURT ORDERS that the Respondents shall not and are permanently enjoined from representing or holding out, directly or indirectly, to members of the public that they are entitled to provide legal services or to practise law in Ontario.

3. THIS COURT ORDERS that the Respondents shall within 7 days of this order remove, delete, destroy or otherwise dispose of all existing promotional material or communications dealing with Westminster Legal Firm Inc. or the provision of legal services or legal information by the Respondents whatsoever and without any limitation, including but not limited to:

- (a) business cards;
- (b) advertisements;
- (c) brochures;
- (d) any websites created, operated or in the control of the Respondents, including the existing sites with the following domain names: wppc.ca; youtube.com; plus.google.com; and kijiji.ca.
- (e) any information in the legal educational videos produced by the Respondents that provides contact information for Abdul Khan or Westminster Legal Firm Inc., directly or indirectly and/or promotes the provision of legal services. The legal educational videos without this information do not need to be removed.

4. THIS COURT ORDERS that Westminster Legal Firm Inc. shall within 30 days of this order be renamed so as not to reference or allude in any manner to the law, legal services or legal information.

5. THIS COURT ORDERS costs in the amount of \$5,000 payable by the Respondents to the Applicant on a partial indemnity basis, payable within 9 months of this order.

6. THIS COURT ORDERS that the Respondents may be served at akhan2006q@gmail.com.
