TREASURER'S REMARKS

The Treasurer welcomed everyone to Convocation including those joining by webcast.

The Treasurer recognized that Convocation is meeting in Toronto which is a Mohawk word that means "where there are trees standing in the water".

The Treasurer acknowledged that Convocation is meeting on the traditional territory of the Mississaugas of New Credit First Nation and acknowledged the Haudenosaunee, and recognized the long history of all of the First Nations in Ontario and the Métis and Inuit peoples. The Treasurer offered these remarks in the spirit of reconciliation and the importance of reminding everyone that we share this land with one another and our Indigenous Peoples.

The Treasurer addressed the protocol for Convocation in the Lamont Learning Centre.

At the Treasurer's request, Convocation observed a moment of silence in honour of those who died and were injured in the event in Toronto on April 23, 2018. The Treasurer expressed condolences and support to their families.

The Treasurer welcomed guests to Convocation: Dan Pinnington, President and CEO, LAWPRO, Steve Jorgensen, Chief Financial Officer, LAWPRO, Alodie Brew, LAWPRO auditor, PricewaterhouseCoopers LLP and Michael Hawtin, Law Society auditor, PricewaterhouseCoopers LLP.

The Treasurer congratulated Dan Pinnington on his appointment as the new President and CEO of LAWPRO.

The Treasurer congratulated Diana Miles on her appointment as the Law Society's Chief Executive Officer on March 8, 2018 and thanked Ms. Miles for her service in the interim period as acting CEO.

The Treasurer congratulated Priya Bhatia on her appointment as Executive Director, Professional Development & Competence.

The Treasurer congratulated Lesley Cameron on her appointment as Executive Director, Professional Regulation Division.

The Treasurer congratulated Robert Burd on his election as chair of the Paralegal Standing Committee for a one year term commencing April 11, 2018.

The Treasurer noted the Paralegal Reception last evening for newly qualified paralegals and the upcoming 10th anniversary celebration of paralegal regulation by the Law Society on May 1, 2018.

The Treasurer congratulated Marilyn Marshall on her appointment as the Law Society's new Complaints Resolution Commissioner effective April 1, 2018, and thanked former Complaints Resolution Commissioner Bernard Morrow for his service.

The Treasurer congratulated Raj Anand on receiving the Ontario Bar Association's 2018 Distinguished Service Award.

The Treasurer noted positive developments on the government relations front both federally and provincially, including support in the Federal budget for expansion of the Unified Family Courts, additional funding for legal aid services to asylum seekers and victims of sexual harassment, provincial legislation to amend the Law Society's name to the "Law Society of Ontario", to amend the *Solicitors Act* respecting contingency fees and to recognize paralegals as officers of the court.

The Treasurer advised Convocation of upcoming events including the Law Society Awards ceremony on May 23, 2018 and congratulated all award recipients.

The Treasurer reminded benchers of the Annual General Meeting on May 9, 2018 and the two motions which have been published in the Ontario Reports and on the Law Society website.

The Treasurer noted the upcoming Federation of Ontario Law Associations (FOLA) plenary, May 9 to 11, 2018 in Toronto and the Workshop on Emerging Legal Technology on May 15, 2018 at the Law Society.

The Treasurer announced the May 22, 2018 launch of the Indigenous Guide for Lawyers Working with Indigenous Peoples in partnership with the Indigenous Bar Association and the Advocates' Society.

The Treasurer reported on his visit to Iqaluit in Nunavut at the invitation of the Chief Executive Officer of the Law Society of Nunavut, Nalini Vaddapalli.

The Treasurer noted upcoming public education events in May and June.

The Treasurer advised Convocation of the passing of Colonel The Honourable Robert Campbell Rutherford, MBE, DC, QC, on April 3, 2018, who also served as a bencher in 1975, and expressed condolences to his family.

The Treasurer welcomed bencher The Honourable Allan Rock, P.C., Q.C., back to Convocation.

The Treasurer noted guests for lunch, including Attorney General of Ontario, The Honourable Yasir Naqvi, MPP, and the board of Legal Aid Ontario.
