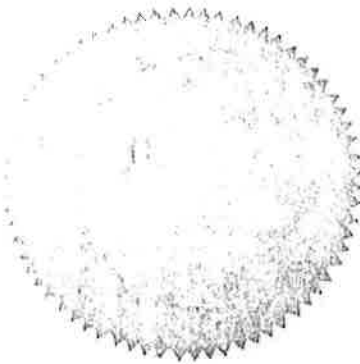

**ORDER**

THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at 330 University Avenue, Toronto, Ontario M5G 1R7.

ON READING the Application Record and Factum and upon hearing the submissions of counsel for The Law Society of Upper Canada,

1. THIS COURT ORDERS that Chantal Coulson (“Coulson”), or any company or business entity controlled by her, is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the “*Act*”).

2. THIS COURT ORDERS that the Respondent Coulson, or any company or business entity controlled by her, is permanently enjoined from advertising or holding herself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*. This includes, but is not limited to:


(a) stating that she is entitled to provide:

- (i) paralegal services; or
  - (ii) legal services;
- (b) stating that she is entitled represent a person in a proceeding before an adjudicative body, including:
- (i) Traffic Court;
  - (ii) Small Claims Court;
  - (iii) Provincial Offences Court;
  - (iv) The Landlord and Tenant Tribunal; or
  - (v) Criminal Court;
- (c) stating that she is entitled to draft any document that affects the legal interests, rights or responsibilities of a person, including:
- (i) court documents;
  - (ii) government documents;
  - (iii) contracts; or
  - (iv) leases;
- (d) publishing an advertisement in any media, including in print or online, advertising any of the above; or
- (e) maintaining any website advertising any of the above.

3. THIS COURT ORDERS that the Respondent Coulson shall forthwith remove the website at <http://www.legalservices2011.webs.com>.

4. THIS COURT ORDERS that the Respondent shall forthwith pay the Applicant its costs of this application fixed in the amount of \$ 17,850.94 .

5. THIS ORDER bears interest at the rate of 3% from its date.
