**ORDER**

THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at Osgoode Hall, Toronto, Ontario M5G 1E6.

ON READING the Application Record, Supplementary Application Record, Second Supplementary Application Record, Factum, and Book of Authorities of the Law Society of Upper Canada (“LSUC”), and upon hearing the submissions of counsel for LSUC and no one appearing for the Respondent,

1. THIS COURT ORDERS that Aspasios Paul Hatzitrifonos (“Hatzitrifonos”) is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the “*Act*”).

2. THIS COURT ORDERS that Hatzitrifonos is permanently enjoined from advertising or holding himself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*.


3. THIS COURT ORDERS that LSUC may in its discretion publish this Order in such media as it deems appropriate.

4. THIS COURT ORDERS that costs are payable to LSUC by Hatzitrifonos in the amount of \$15,940.49.
