ORDER

THIS APPLICATION, for an interlocutory and permanent injunction restraining the Respondent, John Peter Gorman ("Gorman"), from practicing law or providing legal services in Ontario was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Notice of Application, Application Record, Supplementary Application Record, Factum and Brief of Authorities of the Law Society of Upper Canada ("LSUC"),

1. THIS COURT ORDERS that Gorman and any entity or person controlled by him is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the "Act").
2. THIS COURT ORDERS that Gorman is permanently enjoined from advertising and/or holding himself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*.

3. THIS COURT ORDERS that LSUC may in its discretion publish this Order in such media as it deems appropriate.

4. THIS COURT ORDERS that Gorman shall pay to LSUC costs in the amount of \$ 12141.26

5. THIS ORDER BEARS INTEREST at the rate of 2^{1/2} percent per year commencing on Aug. 15/2011.
