THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Notice of Application, the Affidavit of Graham Hanlon sworn on June 4, 2010 and the exhibits attached thereto, and upon reading the affidavit of Malcolm Douglas Morton sworn on August 25th, 2010 and the supplementary affidavit of Graham Hanlon sworn on August 25th, 2010, both filed, and upon hearing the submissions of counsel for the Applicant, no one appearing for the Respondent although duly served with the Application Record and Supplementary Application Record as appears from the affidavit of Chrystal Simpson sworn on June 9, 2010, and the affidavit of Linda Huxted sworn on August 27th, 2010, both filed,


1. THIS COURT ORDERS that the Respondent and any entity or person controlled by him is permanently enjoined from engaging in the practice of law and from engaging in the provision of legal services in contravention of section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended ("the Act").

2. THIS COURT ORDERS that the Respondent is permanently enjoined from holding himself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*.

3. THIS COURT ORDERS that the Applicant Law Society of Upper Canada may in its discretion publish this Order in such media as it deems appropriate.

4. THIS COURT ORDERS that the Respondent shall forthwith pay the Applicant its costs of this application fixed in the amount of \$ 5,126.16 ✓

5. THIS ORDER bears interest at the rate of 2 % from its date.
