## **Admission and call certificate collection. -- 1834-1911. -- 4.5 cm of textual records**

### **Biographical/Sketch/Administrative History**

The Admission and Call Certificate collection is an artificial grouping of records created by the Law Society of Upper Canada Archives. The collection contains miscellaneous Law Society of Upper Canada admission certificates and call to the Bar certificates acquired by the archives over the years from unknown sources.

### **Scope and Content**

Collection consists of miscellaneous admission and call certificates issued by the Law Society of Upper Canada in the 19th century and early 20th century.
