Scope and Content

Fonds consists of minute books that document the proceedings of the Court of General Quarter Sessions of the Peace for the Lunenburg District (1789-1802) and Mecklenburg District (1789-1790, 1793-1800, 1813-1816). The volumes record the dates of the court sittings, names of the defendants, charges, pleas, lists of jurors sworn, verdicts and penalties. One of the volumes also contains marriage oaths from between 1794 and 1827.
