Kenneth Dingwall was admitted as a student-at-law by the Law Society of Upper Canada in 1874, and was called to the Bar in 1877. He practiced law in Hamilton, Ontario.

Fonds consists of records pertaining to the legal education and certification of Kenneth Dingwall, a Hamilton, Ont., lawyer. These records include diplomas and certificates of admission, issued by Canadian and American institutions.
