2017009-001 Mortgage: Daniel and Sarah Wood to John Smith. -- 16 Sept. 1736. -- 1 p. : parchment ; 55.5 x 64.5 cm

Scope and Content

Item is an indenture pertaining to the purchase of a mortgage from Daniel and Sarah Wood of Stisted, Essex, England, by John Smith of Pattiswick, Essex, England for messuage, lands and tenements in Stisted. The indenture is witnessed by Susanna Grimston.

Restrictions

No restrictions on access.

2017009-002 Release and conveyance of Claverings, in Halsted, in Essex: Mr. Charles Humfrey to the Rev. John Houghton. -- 2 Sept. 1779. -- 2 p. : parchment ; 53 x 74 cm

Scope and Content

Item is an indenture pertaining to the purchase of "the freehold...in fee simple of and in the manor, capital messuage or tenement farm lands, grounds and hereditaments called Claverings all situate in Halsted" from Charles Humfrey by the Reverend John Houghton, both of Halsted (now Halstead), Essex, for the sum of two thousand pounds. The indenture is witnessed by William Townsend.

Restrictions

No restrictions on access.

2017009-003 Mortgage for securing 600:0:0 and interest at 5:0:0 per term, per ann.: Mr. John Storer and his trustee to Mr. John Greenwood. -- 14 Sept. 1786. -- 2 p. : parchment ; 60.5 x 78.5 cm

Scope and Content

Item is a mortgage transferred from John Storer of Halsted, Essex, England, to Reverend John Houghton and John Greenwood also of Halsted, pertaining to Plaisters (?) Farm, otherwise known as Wards Farm, in Halsted (now known as Halstead) for the sum of 600 pounds. Item is witnessed by William Townsend.

2017009-004 Mortgage of messuages and lands in Cradley in the County of Hereford and Mathon in the County of Worcester: Mr. William Farmer to Joseph Allen Higgins, Esq.. -- 27 Oct. 1855. -- 3 p. : parchment ; 62 x 78.5 cm

Scope and Content

Item is mortgage purchased from William Farmer of Ledbury by Joseph Allen Higgins of West Bank, near Ledbury, in the County of Hereford, pertaining to buildings and land located in Cradley, County of Hereford, and Mathon, County of Worcester, for 1,200 pounds.

Restrictions

No restrictions on access.
