Biographical/Sketch/Administrative History

Francis James Campbell Newbould received a Bachelor of Laws degree in 1967 from the University of Toronto and a Bachelor of Arts degree in 1964 from Queen's University. He was called to the Bar in 1969, and appointed a Queen's Counsel in 1981. He practiced law in Toronto, first with Tilley Carson & Findlay (1969-1988) and then with the firm of Borden Ladner Gervais LLP. Newbould was appointed a judge of the Superior Court of Justice in 2006. He was a Fellow of the American College of Trial Lawyers, a Member Arbitrator of the ICC International Court of Arbitration and was a Director of Pacific & Western Bank of Canada and of Cuddy International Inc.

Scope and Content

Collection consists of two volumes maintained by Frank J.C. Newbould. The collection includes a case citation notebook maintained by Cyril F.H. Carson and a printed chart of Privy Council decisions with regards to the British North America Act.

Newbould came across the items when cleaning out his office at Borden Ladner Gervais LLP, due to his appointment to the bench.
