John A. Robinson fonds. -- 1872-1882. -- 7 p.

Biographical/Sketch/Administrative History

John A. Robinson was an Ontario lawyer and school teacher. He was admitted as a student-at-law by the Law Society of Upper Canada in 1877, and was called to the Bar in 1882.

Scope and Content

Fonds consists of certificates and commissions relating to the legal and teaching career of John Alexander Robinson. The fonds also includes one hand-written promissory note relating to a financial matter.

985054-001 Promissory note from John Macdonell to Richard Robinson. -- 2 Jan. 1872. -- 1 p. ; 9 x 21 cm

Scope and Content

Item is a hand-written promissory note signed by John Macdonell to pay Richard Robinson of Beverley the amount of \$706.46 with interest at eight per cent.

Scope and Content

Item is a certificate granted by the Board of Examiners for the County of Wentworth allowing John A. Robinson to be a public school teacher. The certificate lists the grades obtained by Robinson in nine subjects.
