ORDER

THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Notice of Application of the Law Society of Upper Canada (“LSUC”), and upon reviewing the Consent of the parties:

1. THIS COURT ORDERS, pursuant to s. 26.3(a) of the *Law Society Act*, R.S.O. 1990 c.L.8 (the “*Act*”), that James William Sinclair (“**Sinclair**”) is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Act*. This includes, but is not limited to, the following services provided verbally, in writing, over the internet, or by video:

- (a) providing advice to clients to assist them in legal proceedings;
- (b) performing legal research for clients to assist them in legal proceedings;
- (c) reviewing documents with clients to assist them in legal proceedings;

- (d) advising clients on legal strategy to assist them in legal proceedings;
- (e) negotiating for clients concerning their legal interests; and
- (f) drafting documents and forms, in whole or in part, for use by clients in legal proceedings;
- (g) drafting documents and forms, in whole or in part, a testamentary document, trust document, power of attorney or other document that relates to the estate of a person; and
- (h) drafting documents and forms, in whole or in part, that relates to the structure of a sole proprietorship, corporation, partnership or other entity, such as a document that relates to the formation, organization, reorganization, registration, dissolution or winding-up of the entity

2. THIS COURT ORDERS that Sinclair is permanently enjoined from advertising or holding himself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*.

3. THIS COURT ORDERS costs payable by Sinclair to LSUC fixed in the amount of \$ 8,900 inclusive within 30 days of this Order.
