ORDER

THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Notice of Application, of the Law Society of Upper Canada ("LSUC"), and upon reviewing the Application Record of the Applicant,

1. THIS COURT ORDERS that Stephen S. Small ("Small") is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the "*Act*").
2. THIS COURT ORDERS that the Respondent Small is permanently enjoined from advertising or holding himself out as a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*, which includes, but is not limited to:
 - (a) Advertising or holding himself out as "counsel";
 - (b) Advertising or holding himself out as a "Law & Management Consultant" or "Law Consultant"; or

(c) Advertising or holding himself out as a person who may practise law or provide legal services in Ontario by way of a "profile" on linkedin.com, or any other website.

3. THIS COURT ORDERS that Small will make best efforts to remove any "profile" on the website linkedin.com which advertises or holds Small out as a person who may practise law or provide legal services in Ontario.

4. THIS COURT ORDERS that the Respondent shall forthwith pay the Applicant its costs of this application fixed in the amount of \$3,500 within 90 days of the date of this Order.

5. THIS ORDER bears interest at the rate of 3% commencing 90 days from its date.
