**ORDER**

THIS APPLICATION, by the Applicant for a permanent injunction against the Respondent was heard this day at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Application Record of the Law Society of Upper Canada ("LSUC"), the Factum of LSUC, and the Book of Authorities of LSUC:

1. THIS COURT ORDERS, pursuant to s. 26.3(a) of the *Law Society Act*, R.S.O. 1990 c.L.8 (the "*Act*"), that Raymond Young ("Young"), or any company controlled by him, is permanently enjoined from engaging in the practice of law or in the provision of legal services in Ontario in contravention of section 26.1 of the *Act*. This includes, but is not limited to, the following services provided verbally, in writing, over the internet, or by video:

- (a) providing legal advice with respect to any legal transaction or claim;
- (b) appearing in a legal proceeding before the Court;
- (c) conducting settlement negotiations of any legal claims or interests;
- (d) drafting pleadings or legal contracts; or

(e) any other conduct that would constitute practicing law or providing legal services under the *Law Society Act*, R.S.O. 1990, c. L.8.

2. THIS COURT ORDERS that Young is to immediately remove his advertisements for legal services located at 4675 Steeles Avenue or any other premises or space controlled by him, and to immediately remove any advertisements for legal services in any newspapers or any other form or medium of public advertisement.

3. THIS COURT ORDERS that Young, or any company controlled by him, is permanently enjoined from

(a) suggesting to clients that he is licensed to practice law in Ontario, or

(b) any other conduct that would constitute advertising or holding him out as a person who may practise law or provide legal services in Ontario in contravention of Section 26.1 of the Act.

4. THIS COURT ORDERS that costs are payable to LSUC in the amount of \$16,000.00.
