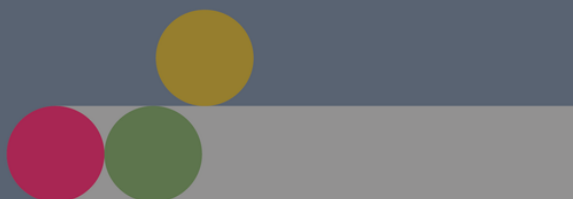
ONE WEEK OF MEAL SERVICE | \$10,000
