THIS APPLICATION made by the Applicant for a permanent injunction against the Respondent, was heard on March 23rd, 2023 by videoconference at the court house located 161 Elgin St., Ottawa, Ontario, K2P 2K1.

UPON READING the Notice of Application, the Application Record of the Law Society of Ontario (LSO), the factum and Brief of Authorities of the LSO, and on hearing the submissions from counsel for LSO, with nobody appearing for the Respondent, despite being given notice of the proceeding:

- 1. **THIS COURT ORDERS** that the Respondent, Mohammed Sarmad Laith Abulwhid also known as Sarmad Laith, Mohammed Abdulwahid, Mohammed Abulwhid, Mohammed Sarmad Abdulwahid ("Abulwhid"), carrying on business as Prince Specialists Sarmad Canadian Consulting Agency, also known as Sarmad Agency ("Sarmad Agency"), and any other company or business entity they control, shall not and are permanently enjoined from holding themselves out as, or representing themselves to be, a person or entity who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Law Society Act*, R.S.O. 1990 c. L.8 as amended (the "Act").
- 2. THIS COURT ORDERS that the Respondent, Mohammed Sarmad Laith Abulwhid also known as Sarmad Laith, Mohammed Abdulwahid, Mohammed Abulwhid, Mohammed Sarmad Abdulwahid ("Abulwhid"), carrying on business as Prince Specialists Sarmad Canadian Consulting Agency, also known as Sarmad Agency ("Sarmad Agency"), and any other company or business entity they control, shall within seven (7) days of the date of this Order remove, delete, destroy or otherwise dispose of all existing promotional material or statements in any print or online media dealing with the practice of law or provision of legal services to the public by the Respondent whatsoever, including but not limited to any and all information on any website for the Sarmad Agency, including https://www.sarmad.ca, that directly or indirectly offers and/or promotes the provision of legal services to the public, including but not limited to legal advice.

- 3. **THIS COURT ORDERS** that the Respondents, Mohammed Sarmad Laith Abulwhid also known as Sarmad Laith, Mohammed Abdulwahid, Mohammed Abulwhid, Mohammed Sarmad Abdulwahid ("Abulwhid"), carrying on business as Prince Specialists Sarmad Canadian Consulting Agency, also known as Sarmad Agency ("Sarmad Agency"), and any other company or business entity they control, shall within seven (7) days of this Order make a written request for the removal of all existing promotional material or statements in any print or online media dealing with the provision of legal services to the public by Abulwhid or the Sarmad Agency about which they are aware and that is not in their control and shall copy counsel for the LSO on all such written requests.
- 4. **THIS COURT ORDERS** that LSO may in its discretion publish this Order in such media as it deems appropriate.
- 5. **THIS COURT ORDERS** that the Respondent shall pay LSO its costs of this Application fixed in the total amount of \$14,600.00, within thirty (30) days of the date of this Order.
