

the Respondent, despite being personally served with the Notice of Motion and having otherwise been given notice of this motion and the hearing,

1. THIS COURT ORDERS that the Respondent Mr. Bey, carrying on business as Moor House Law, is found and declared to be in contempt of court for failing to comply with the Order of the Honourable Justice Pollak dated July 8, 2022 attached as Schedule "A".
2. THIS COURT ORDERS that the Respondent, Mr. Bey, shall be imprisoned for 12 days;
3. THIS COURT ORDERS that the costs are payable by the Respondent to the Law Society in respect of these contempt proceedings in the amount of \$9,191.56, inclusive of disbursements and HST.

THIS Application, made by the Applicant for a permanent injunction against the Respondent, was heard this day by videoconference at the court house, 330 University Avenue, Toronto, Ontario, M5G 1R8.

ON READING the Application Record and Factum of the Law Society of Ontario ("LSO"), and on hearing submissions from counsel for LSO, with nobody appearing for the Respondent, despite being given notice of the proceeding,

1. THIS COURT ORDERS that the Respondent, Cam Ra El Bey, also known as Camron Bey, Cameron Bey, and Cam Raael Bey (“**Bey**”), carrying on business as Moor House Law Firm, also known as Moorish Law Firm (“**Moor House Law**”), and any other company or business entity they control, shall not and are permanently enjoined from practising law or providing legal services in Ontario contrary to section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the “**Act**”).

2. THIS COURT ORDERS that Bey, carrying on business as Moor House Law, and any other company or business entity they control, shall not and are permanently enjoined from holding themselves out as, or representing themselves to be, a person or entity who may practise law or provide legal services in Ontario, contrary to section 26.1 of the Act.

3. THIS COURT ORDERS that the Respondent shall within <sup>14 A.P.</sup> ~~seven (7)~~ days of the date of this Order remove, delete, destroy or otherwise dispose of all existing promotional material or statements in any print or online media dealing with the practice of law or provision of legal services to the public by the Respondent whatsoever, including but not limited to any and all information on any website for Moor House Law, including <https://moorhouselaw.wixsite.com/moorhouselaw>, that directly or indirectly offers and/or promotes the provision of legal services to the public, including but not limited to legal advice.

4. THIS COURT ORDERS that LSO may in its discretion publish this Order in such media as it deems appropriate.

5. THIS COURT ORDERS that the Respondent shall pay LSO its costs of this Application fixed in the total amount of \$4,982.23 inclusive of disbursements and HST, within thirty (30) days of the date of this Order.
