
**ORDER**

1. THIS COURT ORDERS that the Respondent, Robert Mudenge, a.k.a. Jean-Robert Mudenge, a.k.a. Patrick Ewing, a.k.a. Roby Hollywood (“**Mudenge**”), and any other company or business entity he controls, shall not and are permanently enjoined from holding out, directly or indirectly, to members of the public that they are entitled to provide legal services or to practise law in Ontario contrary to section 26.1 of the *Law Society Act*, R.S.O. 1990 c.L.8 as amended (the “**Act**”).

2. THIS COURT ORDERS that LSO may in its discretion publish this Order in such media as it deems appropriate.
