Application under Rule 14.05(2) of the *Rules of Civil Procedure* and s. 26.3 of the *Law Society Act*.

Order

This Application, made by the Applicant, the Law Society of Ontario (“LSO”) for a permanent injunction against the Respondent pursuant to s. 26.3 of the *Law Society Act*, RSO 1990, c. L.8 (the “Act”), was heard on the 30th day of July, 2020 via video-conference, in the presence of the lawyer for the LSO, with nobody appearing for the Respondent despite being duly served and having been provided notice of the hearing of the within Application, On reading the Notice of Application and evidence filed by the LSO and Factum of the LSO, and upon hearing the submissions of counsel for the LSO,

1. This Court orders that the Respondent, Nikolaus Walther Wolf (“Mr. Wolf”), and any company or business entity controlled by him, is permanently enjoined from practising law or providing legal services in Ontario contrary to section 26.1 of the *Act*.
2. This Court orders that Mr. Wolf, and any company or business entity controlled by him is permanently enjoined from holding Mr. Wolf out as, or representing him to be, a person who may practise law or provide legal services in Ontario, contrary to section 26.1 of the *Act*.
3. This Court orders that Mr. Wolf shall provide a copy of this Order to any of his current clients by letter, facsimile transmission, or email message, and copy counsel for the LSO with all such letters, facsimile transmissions, and email messages, as the case may be, within ten (10) days of the date that he is served with an issued copy of this Order.
4. This Court orders that LSO may in its discretion publish this order in such media as it deems appropriate.
5. This Court orders that Mr. Wolf shall pay the LSO’s costs of this Application in the amount of \$8471.00, inclusive of disbursements and HST, within thirty (30) days of the date of this Order.
